### SECTION 3 - COMPOSITION/INFORMATION ON INGREDIENTS

\* Clopyralid is present in this product as the potassium salt, CAS 58509-83-4. The salt is safer as, not being an acid, it does not attack skin and eyes as the parent acid does.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

### SECTION 4 - FIRST AID MEASURES

#### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** No first aid measures normally required. However, if inhalation has occurred, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more than about 30 minutes, seek medical advice.

**Skin Contact:** Quickly and gently brush away excess solids. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. If irritation persists, repeat flushing and obtain medical advice.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed, while holding the eyelid(s) open. Obtain medical advice immediately if irritation persists.

**Ingestion:** If product is swallowed or gets in mouth, wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

### SECTION 5 - FIRE FIGHTING MEASURES

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. This product, if scattered, may form flammable or explosive dust clouds in air.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

**Extinguishing Media:** Suitable extinguishing media are carbon dioxide, dry chemical, foam, water fog.

**Fire Fighting:** If a significant quantity of this product is involved in a fire, call the fire brigade. Do not scatter spilled material with high pressure water jets.

**Flammability Class:** Does not burn.

### SECTION 6 - ACCIDENTAL RELEASE MEASURES

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective chemically resistant clothing including eye/face protection, gauntlets and self contained breathing apparatus. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective goggles. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable Dust Mask. Use a P1 mask, designed for use against mechanically generated particles eg silica & asbestos. Otherwise, not normally necessary.

Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. Refer to product label for specific instructions. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this SDS and the label, instructions on the label prevail. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

### SECTION 7 - HANDLING AND STORAGE

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to

persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this schedule of poison. Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10. Check packaging - there may be further storage instructions on the label.

Exposure limits have not been established by SWA for any of the significant ingredients in this product.

The ADI for Clopyralid is set at 0.5mg/kg/day. The corresponding NOEL is set at 50mg/kg/day. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Data from Australian ADI List, March 2016.

No special equipment is usually needed when occasionally handling small quantities. The following instructions are for bulk handling or where regular exposure in an occupational setting occurs without proper containment systems.

**Ventilation:** No special ventilation requirements are normally necessary for this product. However make sure that the work environment remains clean and that dusts are minimised.

**Eye Protection:** Protective glasses or goggles must be worn when this product is being used. Failure to protect your eyes may lead to severe harm to them or to general health. Emergency eye wash facilities must also be available in an area close to where this product is being used.

**Skin Protection:** You should avoid contact even with mild skin irritants. Therefore you should wear suitable impervious elbow-length gloves and facial protection when handling this product. See below for suitable material types.

## SECTION 10 - STABILITY AND REACTIVITY

---

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Conditions to Avoid:** Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight.

**Incompatibilities:** strong bases, strong oxidising agents.

**Fire Decomposition:** Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Occasionally hydrogen cyanide gas in reducing

atmospheres. Hydrogen chloride gas, other compounds of chlorine. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

### Potential Health Effects

---

#### Inhalation

**Short term exposure:** Significant inhalation exposure is considered to be unlikely. Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

**Long Term exposure:** No data for health effects associated with long term inhalation.

#### Skin Contact:

**Short term exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However product is believed to be mildly irritating, but is unlikely to cause anything more than mild transient discomfort.

**Long Term exposure:** No data for health effects associated with long term skin exposure.

#### Eye Contact:

**Short term exposure:** This product is an eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. If exposure is brief, symptoms should disappear once exposure has ceased.

**Long Term exposure:** No data for health effects associated with long term eye exposure.

#### Ingestion:

**Short term exposure:** Significant oral exposure is considered to be unlikely. However, this product may be irritating to mucous membranes but is unlikely to cause anything more than transient discomfort.

Environmental fate:

**Animals.** In rats, following oral administration, there is rapid and almost quantitative unchanged elimination in the urine.

**Plants:** Clopyralid is not metabolised by plants.

**Soil/Environment:** In soil, microbial degradation occurs. Slow degradation occurs in sterile soil. The major product is carbon dioxide only traces of other metabolites have been recorded. Aerobic soil degradation depends on initial concentration, soil temperature and soil moisture. Although data indicates potential for leaching, field dissipation and lysimeter studies demonstrate fairly rapid degradation and limited downward movement.
