Physical Description & Colour: Clear yellow to brown liquid

Odour: Aromatic odour.

Major Health Hazards: possible skin sensitiser, if aspirated, may cause lung damage. Signs and symptoms associated with mild exposures to organophosphate and carbamate pesticides include: headache, fatigue, dizziness, loss of appetite with nausea, stomach cramps and diarrhoea; blurred vision associated with excessive tearing; contracted pupils of the eye; excessive sweating and salivation; slowed heartbeat, often fewer than 50 per minute; rippling of surface muscles just under the skin. SECTION 5 - FIRE FIGHTING MEASURES

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection.
